These members withdrew from the meeting room while this matter was presented and debated, and returned after it had been considered.

II The Board approved:

- a) the Expansion Project for the *Paraúna*, *Poço Fundo* and *Salto do Paraopeba* Small Hydro Plants; opening of the related tender proceedings; contracting of the related services; and budget allocation for the Project.
- b) The *Generation and Transmission Environmental Investments Program* of the Priority 1 Macroprojects of the Generation and Transmission Directorate for the five-year period 2014-2018; opening/continuation of the tender processes; and acquisition/contracting of the respective equipment, materials and services.
- c) The minutes of this meeting.

III The Board authorized:

- a) Opening of Administrative Proceedings for Tender, in the Price Registry System, and contracting of an insurance company, for supply of Legal Guarantee Insurance, for twenty four months, able to be extended, the maximum total period to be sixty months; and signature of the corresponding Counter-guarantee Agreement for each policy that is issued.
- b) Filing of the necessary legal actions against the federal government to challenge continuation of the requirement for an additional contribution of 10% of the FGTS (Worker Savings Fund) instituted by Complementary Law 100/2001; also applying for suspension of enforceability of the amounts involved, through interim / provisional revenue with or without escrow deposit, and recovery of the amounts paid under this heading over the period January 2010 to December 2012, as awarded by the judgment.
- c) Opening of Administrative Tender Proceedings, and contracting, through a single legal instrument, of the services of implementation and management of the corporate credit card, for payment of travel expenses, such as accommodation, food, air and land transport, and other items, for thirty six months, able to be extended for up to twenty four months, the maximum total period to be sixty months, for:

Cemig, Cemig GT, Cemig D, Cemig Telecomunicações S.A., Axxiom Soluções Tecnológicas S.A., Efficientia S.A., Rosal Energia S.A., Sá Carvalho S.A., Cemig Trading S.A., Cemig Comercializadora de Energia Incentivada S.A. and Empresa de Serviços de Comercialização de Energia Elétrica S.A.

d) Signature of the Term of Assignment for Use of a Real Estate Property, with the State of Minas Gerais, through its Planning and Management Department (Seplag), for assignment, free of charge, for twenty years from publication of summary of the agreement in the *Diário Oficial* (Official Gazette) of Minas Gerais State, for construction, by the Company, of a radio and VHF station, of the property:

Lots 2, 3, 12 and 13 of block 24, with total area 1,440 square meters, in the district of Paula Freitas, in Conselheiro Pena, Minas Gerais State, part of the property with total area 8,991m², registered under N° 2-7.001, Book 2-Y, Page 115, in the Real Estate Property Registry of that municipality.

e) Signature of the Working Agreement with the following units of the Minas Gerais State Limitary Police (PMMG):

the Sixth Environment and Traffic Company -6^{th} CIA PM IND MAT, the Seventeenth Environment and Traffic Company -17^{th} CIA PM IND MAT, and the Eighteenth Environment and Traffic Company -18^{th} CIA PM IND MAT,

to carry out programs of environmental education and protection and policing of forests, fauna, flora and water tables over the whole of their respective territories, preventing hunting and capture of animals, combating deforestation, illegal fishing and clandestine occupations, with a limit of 48 months from signature, but with differing periods so as not to exceed the end of the concession of each generating unit, in the areas of:

- the Camargos and Itutinga hydroelectric plants and
- the Anil, Xicão, Luiz Dias, São Bernardo, Jacutinga and Poço Fundo Small Hydroelectric Plants.



- f) Signature, with the National Electricity System Operator, of
 - the Fifteenth Amendment to Transmission Services Provision Contract 001/2000 and
 - the Twenty-eighth Amendment to Transmission Services Provision Contract 005/1999,

to regularize base payments, and transmission functions of Cemig GT, in accordance with the updating of the Annual Permitted Revenue, ratifying all actions taken since July 1, 2014.

- g) Sponsorship of the *Sports Management Seminar* Project, registered under number 235/2014 in the Minas Gerais State Olympic Sports Incentive Program.
- h) Signature as consenting party of the Contract for Duties under the By-laws, between Aliança Geração de Energia S.A. and Mr. Gilberto José Cardoso, setting terms and conditions for the function of Chief Trading and Engineering Officer of Aliança Geração de Energia S.A., for three years from August 5, 2014, able to be extended, by amendments, for further periods of office.
- i) Signature of the new Stockholders' Agreement of Renova Energia S.A. (Renova), between Cemig GT, RR Participações S.A. (RR) and Light Energia S.A., with Renova as Consenting Party.
- j) Opening of Administrative Tender Proceedings for, and contracting for provision of temporary manpower services services to substitute employees on leave or vacation, or in the event of extraordinary increase of volume of services in the Company, for thirty six months, able to be extended for up to a further 24 months, the maximum total period to be sixty months.
- **IV** The Board oriented the representatives of Cemig GT to vote in favor of the changes to the by-laws at the Extraordinary General Meeting of Stockholders of Renova.
- **V** Resignation: The Chair reported the resignation of Mr. Fuad Jorge Noman Filho as a sitting member of the Board of Directors, as from November 5, 2014, as per a letter in the Company's possession.
- VI Comment: The Chair, the Chief OfficerLuiz Fernando Rolla, the General Manager Wagner Delgado Costa Reis, and the Manager João José Magalhães Soares spoke on matters of interest to the Company.
